# Santa Cruz County Women's Commission 2018 - 2019 Biennial Report

# 1. The Role of the Commission

The Women's Commission is an advisory body to the Board of Supervisors on issues affecting women and girls in Santa Cruz County. The Commission was established to:

- a. Advise the Board of Supervisors on matters affecting any current inequalities suffered by citizens of this County
- b. Make recommendations to the Board of Supervisors to rectify any such inequalities;
- c. Make available to the public information and resources concerning equal rights and opportunities. The Commission shall also maintain a current file of services and resources useful to the community;
- d. Review Santa Cruz County's equal employment opportunity plan and policies and recommend to the Board of Supervisors and the Equal Employment Opportunity Commission any revisions which may be necessary to eliminate employment discrimination against women;
- e. Review Santa Cruz County's rules and job descriptions and make recommendations to the Board of Supervisors and to the Civil Service Commission, as necessary, to assure that any unnecessary barriers to the employment of women are removed;
- f. Study the present and projected needs of women. Develop comprehensive goals to achieve present solutions and effective future planning;
- g. Review pending Federal and State legislation which would impact upon women and, where appropriate, advise the Board of Supervisors of its recommendations;
- h. Exercise any other responsibilities related to the needs and concerns of women and as set forth in the Commission's bylaws as approved by the Board of Supervisors.

## 2. Meetings Dates, Time, and Location

Women's Commission meetings are scheduled for the third Thursday of every month except July and December, from 6:30 until 8:00 PM at the County Government Building (701 Ocean Street, Coastlines Conference Room, Santa Cruz, CA 95060).

In 2018, the regularly scheduled meeting for August was canceled, and a Commission retreat was held on August 26, 2018. One regularly scheduled meeting was held at the Corralitos Women's Club (33 Browns Valley Rd., Watsonville, CA 95076).

In 2019, two regularly scheduled meetings were canceled for lack of quorum, and one regularly scheduled meeting was held in Watsonville at the Watsonville County Government Building (18 W. Beach Street, Watsonville, CA 95076).

### 3. Commission Structure

The Women's Commission is composed of ten voting members; two appointed by each of the five County Supervisors. New officers are elected each year during the April regular meeting. On December 31, 2019, the Women's Commission membership was as follows:

The Commissioner(s) who completed their terms, resigned, or were replaced during the reporting period were Maria Barranco, Marissa Fullum-Campbell, Laura Cross, Melanie Martinez, Carole McPherson, M. Miller, and Margaret Barr.

Commissioners who were appointed during the reporting period were Carrie Beaton, Luci Basor, Jillian Ritter, Laurel Schonfield, M. Miller, and Jenny Sarmiento.

In April 2018, Laura Cross and Theresa Cariño were elected Co-Chairs, and Commissioner Barr was elected to the Executive Committee. In September 2018, Jillian Ritter was elected Co-Chair after Co-Chair Cross resigned.

In April 2019, Jillian Ritter and Theresa Cariño were re-elected Co-Chairs. In December 2019, after Commissioner Barr's resignation, Commissioner Schonfield was elected to the Executive Committee.

#### 4. Commission Staff

The role of *Commissions Coordinator* experienced some turnover during the reporting period. Britt Harmssen, EEO Officer, temporarily staffed the Commission until the position could be filled. In July of 2018, Kaite McGrew was hired as *Commissions Coordinator* and staffed the Commission for the remainder of the reporting period.

Between Commissions meetings, County Staff was available by phone, email, or in person for information and referrals. The County EEO Commissions Office is located in the County Government Center (701 Ocean Street, Room 510, Santa Cruz).

### 6. Commission Activities and Accomplishments

The Commission's priorities and subsequent activities are determined by the Commission's mandate and emerging needs as expressed by the community and identified by the Commissioners.

- Designed and implemented new logos for both the Commission and the Trailblazers project
- Developed a community partner database for future outreach and collaboration efforts
- Implemented a new strategic action plan aligned with mandated scope and purpose of the Commission
- Reviewed new County position descriptions as they became available
- Received reports and reviewed correspondence from members of the public with concerns of interest to women in Santa Cruz County

#### During the reporting period, Commissioners monitored the following emerging issues:

- Senate Bill 826 which establishes quotas for female members of organization boards
- Voting procedure changes to enhance security and accessibility
- County sexual assault response team processes and the availability of Sexual Assault Forensic Exams (SAFE) in Santa Cruz County
- The status of reproductive health education for girls in Santa Cruz County and its potential impact on teen pregnancy and sexually transmitted disease rates
- Santa Cruz County's new Lactation Accommodation Policy
- The scarcity of changing stations and toddler high chairs in County restrooms

## 9. COMMISSION ACCOMPLISHMENTS AND SPECIAL PROJECTS

# During the reporting period, Commissioners took the following actions to address emerging issues:

- Initiated the *Status of Women and Girls Report: Healthcare Section* update by recruiting two Santa Clara University student interns to assist with community outreach, data collection, data analysis and technical writing
- Toured the newly re-opened Blaine Street Women's Facility
- Wrote individual letters to District Supervisors regarding the potential impact of the Dignity-Dominican merger on the availability of women's reproductive healthcare in Santa Cruz County

#### During the reporting period, the Commission participated in the following special projects:

- Initiated the *Women & Homelessness Speakers Series* featuring speakers from community partners providing services to women experiencing homelessness to speak on homelessness issues through a gender lens
- In 2018, presented Trailblazers awards to Heidi Boynton, Kristen Petersen, Susan Greene, Maria Campos and Linda Skeff
- In 2019, presented Trailblazers awards to Casey Coonerty-Protti, Clara Minor, Nicole Keadle, and Margaret Cariño-Condon
- Hosted a luncheon celebrating Trailblazer awardees at the Watsonville Women's Club
- Designed and installed two community art walls celebrating Trailblazers awardees
- The Santa Cruz County Arts Council approved a proposal to create a special exhibit in the County building in 2020 to celebrate 100-years of women's suffrage and encourage women to vote. The Commission will be working with local women artists and consulting with the Museum of Art & History to design the exhibit.
- Assembled and delivered 25 mini-backpack care packages to women at the *Housing Matters Shelter*

### **10. FUTURE GOALS AND RECOMMENDATIONS**

#### In the coming year, the Women's Commission will endeavor to accomplish the following:

- Actively recruit for Commissioners to fill vacant seats
- Present the updated healthcare section of the SOWAG report to the Board of Supervisors
- Present Trailblazers Awards to community members who advance the interests of Santa Cruz County women and girls
- Design and install an exhibit to celebrate women's suffrage and encourage voter participation
- Continue and complete the Women and Homelessness Speaker Series
- Update Commission Bylaws to reflect changes in procedure and changes to Brown Act notice requirements, as well as consistency of language where appropriate
- Promote participation in the 2020 Census, particularly with difficult-to-count groups
- Promote civic engagement and voter participation for women in the 2020 elections
- Continue to monitor development of the County EEO & CC Plans
- Establish a Policy Review Subcommittee to review policies and legislation
- Establish a Public Service and Civic Engagement Subcommittee to encourage youth voter participation and promote a greater presence of women in leadership roles
- Further develop our community partner outreach database and develop an easily accessible database of resources for women

# In the coming year, the Women's Commission recommends that the Board of Supervisors take the following actions:

- Continue to actively recruit to fill the vacancies in District 3 and District 5
- Provide policy leadership requiring that all County data and data provided by County-funded organizations (as a condition of grant-funding) be disaggregated by gender so that gender disparities in services and outcomes can be identified and addressed
- Address the scarcity of changing stations and restroom stall high chairs in County restrooms
- Continue to provide policy leadership and funding support for programs tasked with 2020 Census outreach to difficult-to-count community members
- Continue to provide policy leadership and funding support for County programs designed to ensure that the 2020 elections are accessible and promote voter participation
