1. Call to Order/Roll Call/Introductions

Meeting convened at 6:32 PM.

2. Review and Approve Agenda

Motion/Second: Ritter/Barr **Motion passed unanimously.**

3. Review and Approve June 20, 2019 Meeting Minutes

Motion/Second: De Lany/Beaton **Motion passed unanimously.**

4. Correspondence

Commissioners reviewed current new County position descriptions and a letter from Conscience and Action.org regarding a Santa Cruz woman recently made homeless.

5. Public Comment: None

6. Reports of Officers and Subcommittees

6.1. <u>Co-Chairs Report:</u> Commission discussed preparations for a proposed retreat. Details to be determined. Ritter has a banner printing resource for the Trailblazer banner.

6.2. Status of Women and Girls (SOWAG) Report: Health Care Update

Staff reported on Phase 1 progress: Intern has been unavailable due to a family crisis. Of the 69 identified interviews, 25% have been completed, 7% have declined to participate, and 68% are still in process. Anonymous online patient survey drafts in County approval process, and an outreach campaign has been drafted. Primary data sources will be the 39 community reports collected. Husin reported that data extraction process has been implemented and is 50% complete.

6.3. Women and Homelessness Speaker Series

Commission reviewed a proposal to invite a series of speakers to educate the Commission and community on homelessness services and programs as viewed through a gender lens. Meetings would be held in the Board Chambers and expanded to 2 hours featuring speakers from 7-8 PM. Commission hopes to include women who utilize

homeless services. Minutes would include information about available services/programs and take-aways would be collected and available on-line after the series. Subcommittee will meet to discuss measurable outcomes. Series would begin at the October regular meeting. Trejo suggested including women who are veterans.

Authorize County Staff to proceed with the Speaker Series as proposed.

Motion passed unanimously.

6.4. Justice and Gender Task Force Update:

Cariño reported that funding for the Task Force will be ending this year when they will make their remaining recommendations to the Board of Supervisors. However, there is a possibility that it will transition into a County Commission (a restructured Domestic Violence Commission).

6.5. Public Awareness Update

Beaton reported an increase in Facebook followers and post views (+200%) and engagement. Instagram followers increased (+16). Commissioners are encouraged to engage with posts. Trejo suggested creating a Commission Linked In account.

Commissioners reported on Commissioner activities for Q3, including 2 new interns, progress, meetings with additional

The Commission reviewed the recently updated County Lactation Accommodation Policy and the Board agenda item in which the Breastfeeding Coalition acknowledged the Board for supporting working women with a model lactation accommodation policy and declaring August 2019 as Breastfeeding Awareness Month. Commission discussed the availability of changing stations and toddler seats in County building restrooms.
