5. New Business/Action Items:

5.1. Consider Advocating for Menstrual Equity

Commission discussed recent legislation (AB 367) mandating the provision of menstrual products in California public schools and discussed advocating for similar provisions in County facilities. Hartman, author of a recent Sentinel article on menstrual equity in Santa Cruz County, advised the Commission that Santa Clara County collaborated with community agencies to fund implementation of menstrual equity in their county. Murray will research the specifics that would be involved to be included in an initial advocacy letter to the Board of Supervisors as correspondence at the January 11, 2022 with a long term view to advocating for Supervisor sponsorship elevating the topic to the consent agenda eventually.

Motion authorizing Chairs to send a letter to the Board of Supervisors advocating for menstrual equity in County facilities.

Santa Cruz County Women's Commission 2020 - 2021 Biennial Report

1. The Role of the Commission

The Women's Commission is an advisory body to the Board of Supervisors on issues affecting women and girls in Santa Cruz County. The Commission was established to:

- a. Advise the Board of Supervisors on matters affecting any current inequalities suffered by citizens of this County
- b. Make recommendations to the Board of Supervisors to rectify any such inequalities;
- Make available to the public information and resources concerning equal rights and opportunities. The Commission shall also maintain a current file of services and resources useful to the community;
- d. Review Santa Cruz County's equal employment opportunity plan and policies and recommend to the Board of Supervisors and the Equal Employment Opportunity Commission any revisions which may be necessary to eliminate employment discrimination against women;
- e. Review Santa Cruz County's rules and job descriptions and make recommendations to the Board of Supervisors and to the Civil Service Commission, as necessary, to assure that any unnecessary barriers to the employment of women are removed;
- f. Study the present and projected needs of women. Develop comprehensive goals to achieve present solutions and effective future planning;
- g. Review pending Federal and State legislation which would impact upon women and, where appropriate, advise the Board of Supervisors of its recommendations;
- h. Exercise any other responsibilities related to the needs and concerns of women and as set forth in the Commission's bylaws as approved by the Board of Supervisors.

2. Meetings Dates, Time, and Location

Women's Commission regular meetings are scheduled for the third Thursday of every month except July and December, from 6:30 until 8:00 PM. During the reporting period, the Commission met remotely or at the County Government Building (701 Ocean Street, Santa Cruz, CA 95060).

During 2020, three regularly scheduled meetings were canceled for health and safety reasons
during the pandemic immediately following Governor Newsom's initial Stay-at-Home order,
two meetings were canceled for lack of quorum, two meetings were held in person and four
meetings were held remotely, including a special meeting in July to address ongoing projects
impacted by regular meeting cancelations.

• During 2021, one regularly scheduled meeting was canceled for lack of quorum, and all other meetings were held remotely.

3. Commission Structure

The Women's Commission is composed of ten voting members; two appointed by each of the five County Supervisors. New officers are elected each year during the April regular meeting. On December 31, 2021, the Women's Commission membership was as follows:

The Commissioner(s) who completed their terms, resigned, or were replaced during the reporting period were Carrie Beaton, Luci Basor and Jenny Sarmiento. In April 2020, Jillian Ritter and Theresa Cariño were elected Co-Chairs. In April 2021, Jillian Ritter and Vanessa Quiroz-Carter were elected Co-Chairs.

6. Commission Activities and Accomplishments

The Commission's priorities and subsequent activities are determined by the Commission's mandate and emerging needs as expressed by the community and identified by the Commissioners.

Social Media Subcommittee

Authorized to maintain the Commission's social media accounts. As of December 31, 2021, subcommittee members included Commissioners Bickert, Cariño, Boutell and Campbell

Art Wall Subcommittee

Authorized to design and install an annual community art wall in the County Building. As of December 31, 2021, subcommittee members included Commissioners Campbell, Ritter, Cariño, and Boutell.

Trailblazer Awards Subcommittee

Authorized to plan and implement the Commission's semi-annual Trailblazer Awards Ceremony, including recommending awardees to the Commission and planning the presentation of awards, and coordinating with the Art Wall Subcommittee as needed to celebrate awardees with an exhibit whenever possible. As of December 31, 2021, subcommittee members included Commissioners Campbell, Ritter, Cariño and Boutell.

Community Resource and Partner Database Subcommittee

Authorized to collect, vet, curate and share resources with the community and to establish and maintain a community partner database for collaborative purposes. As of December 31, 2021, Co-Chair Ritter was the only subcommittee member.

Ad Hoc Advocacy Subcommittees

Subcommittees tasked with advocating for the advancement of women's interests in Santa Cruz County

Political Participation and Civic Engagement Subcommittee

Authorized to advocate for and promote the political participation and civic engagement of women in Santa Cruz County, to stimulate women's interest in candidacy, identify barriers to women running for office, educate young women on the political process and identify partner organizations. As of December 31, 2021, subcommittee members included Commissioners Bickert, Schonfield, De Lany and Quiroz-Carter.

Policy and Legislation Subcommittee

Authorized to review policies and legislation and bring advocacy opportunities to the Commission for consideration. As of December 31, 2021, subcommittee members included Commissioners De Lany, Schonfield, and Ritter.

COVID-19 Response Subcommittee

Authorized to monitor County and community pandemic response efforts in support of disproportionately impacted women and families and to bring advocacy and impact opportunities to the Commission for consideration. As of December 31, 2021 subcommittee members included Commissioners Cariño and Bickert.

Black Lives Matter/Anti-Racism Subcommittee

Authorized to monitor County anti-racism efforts and bring opportunities for advocacy related to race/ethnicity to the Commission for consideration. As of December 31, 2021, subcommittee members included Commissioners Schonfield, Boutell and Campbell.

Ad Hoc Status of Women and Girls Subcommittees (SOWAG)

Subcommittees tasked with monitoring issues related to the broad categories established by the California Commission on the Status of Women and Girls

Homelessness Subcommittee

Authorized to monitor the status of women experiencing homelessness in Santa Cruz County and bring opportunities for education, advocacy and impact to the Commission for consideration. As of December 31, 2021, subcommittee members included Commissioners Cariño, Ritter, Schonfield, and De Lany.

Economic Justice Subcommittee

Authorized to monitor financial disparities impacting women in Santa Cruz County and bring opportunities for education, advocacy and impact to the Commission for consideration. As of December 31, 2021, subcommittee members included Commissioners De Lany, Schonfield and Quiroz-Carter

9. COMMISSION ACCOMPLISHMENTS AND SPECIAL PROJECTS

<u>During the reporting period, Commissioners took the following actions to address emerging issues:</u>

- Actively recruited for Commissioners to fill vacant seats, resulting in all seats being filled for the majority of the reporting period.
- Completed and submitted the updated healthcare section of the SOWAG report to the Board of Supervisors
- Promoted participation in the 2020 Census, particularly with difficult-to-count groups
- Promoted women's civic engagement and voter participation, particularly for women in underrepresented groups during the 2020 elections
- Continued to monitor development of the County's Equal Employment Opportunity and Cultural Competence Plans
- Continued to expand the community partner database for outreach and collaboration efforts
- Reviewed the County's Equal Employment Opportunity and Cultural Competence Plan and provided detailed feedback
- Reviewed a draft of the County's Diversity, Equity and Inclusion Employee Survey to provide feedback
- Advocated for Board of Supervisors support for the Equal Rights Amendment
- Advocated with the Board of Supervisors in support of 2020 Census participation
- Joined the National Association of Commissions for Women (NACW)

- Voted to join the Association of California Commissions for Women (ACCW) when they begin accepting new memberships
- Discussed the impact that growing up in a culture that primarily recognizes men in its naming conventions (schools, hospitals, parks, etc.) has had on the aspirations of girls and women.
- Began research into the feasibility of implementing the same menstrual equity standards in County facilities as those provided for California schools in Assembly Bill 367

During the reporting period, the Commission participated in the following special projects:

- Designed a new logo for the 2021 Trailblazers project and established new award categories including Economic Justice Leadership, Crisis Response Leadership, Anti-Racism Leadership, Cultivating Youth Leadership, and the Phoenix Award recognizing women who lead despite significant challenges. Nominations were solicited, awardees and a hybrid in-person/virtual event was planned but ultimately cancelled for health and safety reasons during the pandemic. Awardees will be presented with their awards once it becomes safe to congregate again
- Hosted the *Women and Homelessness Speaker Series* although it was suspended early in 2020 for health and safety reasons during the pandemic.
- Celebrated the 2020 Centennial Anniversary of Women's Suffrage with a multi-wall exhibit in the County Building. The "Be The Voice" art wall featured six commissions works of art from six local women artists re-creating vintage suffrage posters with modern, inclusive imagery depicting issues that continue to impact marginalized groups. The "Voices Through Time" timeline (in collaboration with Rosemary Brogan, Cabrillo Women's History Professor) explored 100 years of California's diverse history which proved foundational to California's early adoption of women's suffrage and created the momentum needed to support adoption of the 19th Amendment to the United States Constitution. The exhibit remained open to the public for four months and a virtual tour of both the art wall and the timeline remain available on the Commission's website.
- Completed the Status of Women and Girls Report: Health Care Section Update, a high-level
 review of the status of health care for women and girls in Santa Cruz County that draws on
 data from multiple national, State and local data sources including interviews with key
 stakeholders in the medical community, reports from 16 community partners, and articles
 and data from 40 additional sources. County Staff worked with Santa Clara University interns
 to collect and analyze data summarizing key health care issues for women and girls in Santa
 Cruz County.

10. FUTURE GOALS AND RECOMMENDATIONS

In the coming year, the Women's Commission will endeavor to accomplish the following:

- Update and submit the Political Participation section of the SOWAG report to the Board of Supervisors
- Present Trailblazers Awards to community members who advance the interests of Santa Cruz County women and girls
- Design and install a community art wall exhibit celebrating 2022 Trailblazers awardees
- Continue the Women and Homelessness Speaker Series

- Update Commission Bylaws to reflect changes in procedure and changes to Brown Act notice requirements, as well as consistency of language where appropriate
- Continue to monitor development of the County Equal Opportunity and Cultural Competence Plan
- Further develop our community partner outreach database and develop an easily accessible library of resources for women in Santa Cruz County

In the coming year, the Women's Commission recommends that the Board of Supervisors take the following actions:

Actively recruit to fill the Commission vacancies in District 3 and District 4

- Provide policy leadership requiring that all County data and data provided by County-funded organizations (as a condition of grant-funding) be disaggregated by gender so that gender disparities in services and outcomes can be identified and addressed
- Policy leadership and prioritize policies, programs and legislation designed to address racial/ethnic disparities and inequities impacting women in Santa Cruz County
- Address the scarcity of changing stations and restroom stall high chairs in County restrooms



SANTA CRUZ COUNTY WOMEN'S COMMISSION'S

TO ASSEMBLY BILL 361 ALITHOPIZING TELECONFERENCE MEETINGS AS

FINDINGS PURSUANT TO ASSEMBLY BILL 361 AUTHORIZING TELECONFERENCE MEETINGS AS A RESULT OF THE CONTINUING COVID-19 PANDEMIC STATE OF EMERGENCY AND HEALTH OFFICER RECOMMENDATION FOR SOCIAL DISTANCING

WHEREAS, The Santa Cruz County Women's Commission is a legislative body under the Brown Act as defined under Cal. Gov. Code section 54952(b) and Santa Cruz County Code Section 2.38.110; and

WHEREAS, on September 16, 2021, Governor Newsom signed Assembly Bill 361 ("AB 361"), urgency legislation effective immediately, that amended Government Code section 54953 to permit legislative bodies subject to the Brown Act to continue to meet under modified teleconferencing rules provided that they comply with specific requirements set forth in the statute; and,

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(1)(A), a legislative body may meet under the modified teleconferencing rules during a proclaimed state of emergency, and where local officials have imposed or recommended measures to promote social distancing; and

WHEREAS, on March 4, 2020, Governor Newsom issued a Proclamation of State of Emergency in response to the COVID-19 pandemic, and which remains in effect; and

WHEREAS, on September 30, 2021, Santa Cruz County Public Health Officer Dr. Gail Newel strongly recommended that legislative bodies in Santa Cruz County continue to engage in physical/social distancing by meeting via teleconference as allowed by AB 361 and confirmed that she will regularly review and reconsider this recommendation and notify the public when it is no longer recommended; and

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(3), within 30 days of the date the legislative body first holding a teleconferenced meeting under the modified rules, and every 30 days thereafter, a legislative body can continue to hold such teleconference meetings provided it has reconsidered the circumstances of the state of emergency and determined either that the state of emergency continues to directly impact the ability of the members to meet safely in person or that local officials continue to recommend measures to promote social distancing; and

WHEREAS, on January 20, 2022, The Santa Cruz County Women's Commission held a teleconference meeting under AB 361; and

WHEREAS, this Santa Cruz County Women's Commission has reconsidered the circumstances of the current state of emergency and finds that the COVID-19 pandemic continues to directly impact the ability of members of the public to participate safely in person and further finds that the Santa Cruz County Public Health Officer continues to recommend measures to promote social distancing; and

WHEREAS, in the interest of public health and safety, and due to the emergency caused by the spread of COVID-19, the Santa Cruz County Women's Commission deems it necessary to utilize the modified teleconferencing rules set forth in AB 361;

NOW, THEREFORE, the Santa Cruz County Women's Commission makes the following findings by a majority vote:

Section 1. The foregoing recitals are true and correct, and adopted as findings of the Santa Cruz County Women's Commission.

Section 2. Effective immediately, and for the next 30 days, the Santa Cruz County Women's Commission will meet via teleconference as authorized under AB 361 and Government Code section 54953(e)(3).

Section 3. No later than thirty (30) days from making today's findings, or at the next scheduled meeting, the Commission will reconsider the circumstances of the COVID-19 state of emergency and, if necessary, adopt subsequent findings to continue holding teleconference meetings in accordance with Government Code section 54953(e)(3).
